**NOTICE TO PETITIONER**

The Prosecutor may object to this petition within 10 days of receiving a copy and may request a hearing. If an objection is received from the prosecutor within 10 days the court will schedule a hearing. At the hearing the prosecutor will be required to establish beyond a reasonable doubt that the petitioner knowingly or purposely obtained, purchased, transported, or possessed, actually or constructively, or had under his or her control, marijuana in an amount exceeding 3/4 of an ounce.
