HB 620 is introduced in the Senate and referred to the Senate Judiciary Committee.

Senate Judiciary Committee holds a public hearing on HB 620.

Kimon S. Zachos, co-chairman of the Joint Interim Committee, reports to the House on the activities of the Committee.

July 1
