[PROPOSED] ORDER AUTHORIZING AND DIRECTING RELEASE OF CERTAIN EMPLOYEE PERSONNEL FILES

Plaintiffs represented by Nixon Peabody LLP and Rilee & Associates, P.L.L.C. in these consolidated actions ("Plaintiffs") have filed an *Assented-to Motion for Court Order Authorizing and Directing Release of Certain Employee Personnel Files* ("Assented-to Motion") with a proposed order attached. Defendant New Hampshire Department of Health and Human Services ("DHHS") has assented to the relief sought in the *Assented-to Motion*, including the form of the proposed order.

In the Assented-to Motion, Plaintiffs represent that:

- A. Plaintiffs served their First Combined Set of Requests for Production of Documents ("First RFPs") on October 13, 2022. On November 30, 2022, Plaintiffs served their Second Combined Set of Requests for Production of Documents. And, on December 16, 2022, Plaintiffs served their Third Combined Set of Requests for Production of Documents ("Third RFPs").
- B. Both the First RFPs and Third RFPs seek production of "personnel files and records relating to" certain named employees of the Sununu Youth Services Center, Youth Development Center, Youth Development Services Unit, and their predecessor or adjunct entities (collectively, the "Sununu Center"), on the grounds that the personnel files of the named individuals may contain relevant evidence, including but not limited to performance evaluation forms, disciplinary actions, and letters of complaint that reference alleged or reported abuse of Plaintiffs or other residents. The 37 named individuals are listed in Exhibit 1 to this order.
- C. Personnel records of State employees are held both in the human resources departments of the agencies they worked for (the "agency personnel file") and at the Department of Administrative Services' Division of Personnel (the "permanent personnel file"). ¹ The two types

¹ This Court recognizes that the "permanent personnel files," as defined in CAR Per. 1501-03 of the 37 employees listed on Exhibit 1, are held by the Division of Personnel, which is neither a party to, nor represented in, this Consolidated Action (nor is it a unit of DHHS). Solely for the purposes of this Order,

of personnel files are not identical though the release of both is governed by N.H. Code Admin. R. ("CAR") Per. 1501.02.

- D. Pursuant to CAR Per. 1501.02, the contents of employee personnel files may only be released in response to the Plaintiffs' discovery requests pursuant to "an order of a court of competent jurisdiction" or "upon written authorization signed by the employee whose records are affected."
- E. In order for DHHS to comply with the discovery requests propounded upon it, the *Assented-to Motion* requests that this Court issue an order authorizing and directing DHHS and the Division of Personnel to release the personnel files of the 37 named individuals in response to Plaintiffs' discovery requests in this matter.
- F. Plaintiffs agree to treat the employee personnel files according to the confidentiality designations made by DHHS or the Division of Personnel pursuant to the Stipulated Protective Order in this matter.
- G. Plaintiffs further agree that those requested personnel files are for those individuals who are defendants or witnesses or could be defendants or witnesses in these consolidated lawsuits or in a related criminal matter.
 - H. WHEREFORE, this Court orders as follows:

DHHS and the Division of Personnel are hereby authorized and directed, pursuant to CAR Per. 1501.02, to release to Plaintiffs, solely for purposes of this litigation, the "agency personnel file" and "permanent personnel file," described in CAR Per. 1501.03(a) and (b), respectively, for the 37 employees listed in Exhibit 1 hereto.

Plaintiffs shall treat the employee personnel records produced by DHHS pursuant to this Order according to the confidentiality designations made by DHHS pursuant to the Stipulated Protective Order in this matter.
