Happy New Year!

Happy New Year, Mediators and Neutrals! Some highlights from 2023 include:

The fee for divorce/parenting mediation increased from \$300 to \$450. The repayment requirement for the ADR Fund with Children was removed from RSA 461-A:7, and the ADR Fund eligibility for divorce/parenting mediation expanded from under 200% FPL to under 250% FPL. The ADR Office also received additional AV Grant funding which we used to create brochures, translate forms, and subtitle videos, and create new videos. And for divorce/parenting cases, the ADR Office increased the number of Neutral Case Evaluations through contracting with Judge Gordon to provide NCE services.

For the Voluntarily Mediated Agreements program, the ADR Office invited students from Harvard's Dispute System Design Clinic to interview stakeholders, evaluate the VMA process and provide recommendations to improve the quality of VMAs. Their project led to the creation of a new VMA Mediation Summary Form and a combined form for DCYF and birth parents to request VMA mediation.

The ADR Office converted the landlord-tenant program in Concord District Court from asynchronous remote mediation to in-person same-day mediation, in partnership with the court and 603 Legal Aid. Resolution Systems Institute conducted a process and outcome evaluation on the pre-filing Eviction Diversion Program, which concluded that even after rental assistance was no longer available, the percentage of mediations that resulted in agreement did not change. Additionally, the ADR Office transitioned from ERA funding to HUD CPF Grant funding to be able to continue our landlord-tenant programs.

And lastly, we are bringing in Audrey Lee and David Hoffman to provide a long-awaited training for NH Mediators, with a focus on skills applicable to Rule 32 and District Court mediation.

It is an honor to be able to support you all and the amazing work that you do. Thank you for serving the people of NH. Thank you for your empathy, professionalism, and creativity.
