Confidentiality Exceptions Resources Reminder

Just a reminder, that in emergency situations such as the ones outlined below, the mediator may (or must) break confidentiality to address the situation.

Child Abuse: Per RSA 169-C:29, "any person having reason to suspect that a child has been abused or neglected shall report the same." Please visit DHHS's website for more information: https://www.dhhs.nh.gov/report-concern/report-child-abuse

Elder Abuse: Per RSA 161-F:46 "any person... suspecting or believing in good faith that any adult who is, or who is suspected to be vulnerable, at the time of the incident, has been suspected to abuse, neglect, self-neglect or exploitation, or is, or was living in hazardous conditions shall report..." Violence towards the self or others: Threats of violence to self or others are exceptions to the confidentiality rules that govern mediation. If you suspect that there is imminent danger, please dial 911. If you have reason to believe that a party is experiencing "suicidal, substance use, and/or mental health crisis, or any other kind of emotional distress" please call 988 to reach the Suicide and Crisis Lifeline.
