The Rule 32 Refresher training deadline has been extended until February 29, 2023 through Administrative Order 2023-04. Rule 32 mediators can fill out the confirmation of the requirements using the attached form.

First Appearance Video - Divorce/Parenting Mediation

The First Appearance Video, which is required by all parents going through the divorce or parenting process to watch, now has subtitles available in English, Spanish, French, Portuguese, and Arabic. Reminders

Two gentle reminders of general best practices and policies:

- 1. <u>Third party participants:</u> With limited exceptions, third party participants (meaning people who are not parties to the case or their attorneys) are *not allowed at mediation* unless agreed upon by both parties and the mediator.
- **2. Communication and ADR Reports**: Please maintain a healthy communication channel with the courts that have referred cases to you. Among their many tasks, court staff are also charged with stewarding cases through the court process. As such, confirmations of emails, updates on the status of the mediation, and responding to emails in a timely manner can make a world of difference in terms of their workload and stress. *Please file ADR reports within 7 days of a mediation*.

LT Mediation - Update - Data Collection - Finalizing Forms

We have received a fully executed agreement from HUD regarding the CPF Grant and an approved action plan! We are in the process of creating a new form for the post-filing landlord-tenant mediation program. **Data collection using the new process is likely to start January 1, 2024.** Please stay tuned.

Feedback Requested - Mediation Questionnaires

Mediators should be providing parties with Mediation Questionnaires at the end of each mediation. The ADR Office is considering implementing a text messaging system to send mediation questionnaires to parties through text after the mediation occurs. If you have any feedback on this idea, please email me at mhuang@courts.state.nh.us. Depending on the feedback received, the goal would be to pilot this program with Divorce/Parenting Mediation sometime in late spring/summer of 2024.

Rescheduling Working Group - Divorce/Parenting Mediation

The ADR Office has put together a working group to discuss the issue of excessive rescheduling in divorce/parenting cases. The group consists of two mediators, two attorneys, two case managers, a judge and a clerk. Our first meeting will be held in December.
