## **Divorce/Parenting Qualified Interns**

Back in 2022, a bill passed which amended RSA 328-C, RSA 458:15-c and RSA 461-A to allow qualified interns to participate in court mediations under the supervision of a certified family mediator. We received our first qualified intern request in January, yay! As a reminder, the protocol for qualified interns to participate in court mediation is the following:

- 1. 1.If a court-contracted divorce/parenting mediator plans to be a contracted supervisor and take on qualified interns, the mediator will email the Office of Mediation and Arbitration ("ADR Office") and the courts assigned with the attached attestation.
- 2. The ADR Office will keep a copy of the attestation in the supervising mediator's file.
- 3. The ADR Office will keep an excel file with the names of the supervisors, the interns, and their start and end dates.
- 4. The contracting supervisor shall obtain consent from the parties regarding the role of the intern.
