## Divorce/Parenting Mediations – Fund eligibility at 250% FPL

Effective January 31, 2024, the monthly gross income threshold for a party to be eligible for a court-appointed divorce/parenting mediator to be paid by the court fund is at or below 250% of the Federal Poverty Line. Please see Administrative Order 2024-04 for more details:

This increase in threshold was piloted starting in July 2023 and will continue indefinitely. Reminder: Please remember to provide grant-eligible parties with the data collection form. We are required to provide the data collected to DHHS as a condition of the grant.

### Small Claims/Landlord-Tenant mediation fee change

Starting on **March 18, 2024**, the fee for small claims/landlord-tenant mediations will be increased to \$90 per case.

Furthermore, starting on **March 18, 2024**, if a mediator is assigned to and attends a small claims or landlord-tenant session and is does not receive any mediations, the mediator can submit a Mediator Statement for Payment asking to be compensated \$90. Only one request for compensation can be made per ½ day session.

#### Rule 32 Continuing Education Report Deadline Passed
