Legislation that May Impact Divorce/Parenting and Guardianship Mediation

Below are three bills that were signed into law last Friday that divorce/parenting mediators and guardianship mediators should be aware of. Please look into the effective date of the legislation.

- HB 1118 (Determination of Parental Rights and Responsibilities Following the Death of a Child's Parent or Guardian): "In cases where the court is addressing temporary or permanent parental rights and responsibilities due to either the death of a parent or the death of a guardian who has served in that capacity for the child for at least 2 years, the court shall consider, as part of its determination as to the best interests of a child, the contact the child has had with the surviving parent and/or the wishes of the deceased guardian as provided in estate planning documents."
- HB 1244 (Consent to Medical and Dental Treatment of Children in Schools):
 "Participation in any school-based oral health program shall require explicit written consent of the child's parent or legal guardian."
- <u>HB 1303 (Relative to Causes for Absolute Divorce):</u> This bill revises the grounds for absolute divorce in the case of habitual drunkenness to include drug abuse.

Notice for Non-Payment of Mediation (Divorce/Parenting)

A gentle reminder that the ADR Office does not cover the divorce/parenting mediation fee for a party who is considered private pay. If a mediator is unable to collect payment from a party who is private pay, the mediator may submit the Notice of Non-Payment of Mediator Fee (NHJB 2743), which can be found here:

The Court should then raise the issue of non-payment with the non-paying party at the next regularly scheduled court hearing.
