## **Divorce/Parenting Mediator and Case Manager Summit**

Please save the date! The annual Case Manager-Mediator Summit will be held on **September 15, 2023 from 9am-3pm**. The summit will be held **in-person at One Granite Place**. We look forward to seeing you then!

The 2022 Case Manager-Mediator Summit has been approved for 5 hours of continuing education by the Office of Professional Licensure and Certification (2.5 hours of family relationships; .75 hours legal update, 1.75 hours other). ### **Divorce/Parenting Mediation Fee Changes**

Starting July 1, 2023, the court will begin issuing Notices of Appointment with the increased fee of \$225 per party or \$450 per 4 hours of mediation and one hour of administrative work.

If you have not done so already, please fill out, sign, and return the updated contract as soon as possible. Prior contracts restricted the amount that a mediator could receive from the AV grant to \$150 per party.

The Circuit Court has issued AO 2023-06, which expands eligibility for the ADR fund from at or below 200% of the Federal Poverty Line to at or below 250% of the Federal Poverty Line for a pilot period of July 1, 2023 – January 30, 2024.

SB 129 will be effective August 23, 2023, which eliminates the repayment requirement for fund with kids.

#### **Mediation Questionnaires**

Please continue to send mediation questionnaires to parties at the end of a mediation. Earlier this year, you may have received an email from Carissa Carkhuff with comments from parties about their mediation experience that the ADR Office has received through mediation questionnaires. Mediation questionnaires are an easy way for parties to express their thoughts about the mediation process. From our responses, we know that regardless of whether a mediation settles, 93.98% of respondents say they would use mediation again if needed. We will begin to send out mediation questionnaire responses to mediators at the end of every month starting this month.
