Minor Guardianship Mediators Wanted

The New Hampshire Judicial Branch Office of Mediation and Arbitration is currently accepting applications for mediators to contract for **Minor Guardianship mediation assignments**. Mediators will be paid for their services based upon the amount listed in the Statement for Payment. Qualified applicants must have completed a 40-hour mediation training, have 5 years' experience as a mediator, and be able to travel regionally within NH. Experience and knowledge in the areas of minor guardianship, child development, mental health issues and substance abuse issues are helpful. **Mediators who are willing to travel to courts in Coos, Carroll and Grafton Counties are strongly encouraged to apply.** Applications will be accepted through July 22, 2022 through email at mhuang@courts.state.nh.us or by mail. Small Claims/Civil Mediators Wanted

The New Hampshire Judicial Branch Office of Mediation and Arbitration is currently accepting applications for mediators to contract for **Small Claims and Civil mediation assignments**. Mediators will be paid \$80 per small claims case, and \$175 per civil case. Qualified applicants must have completed a 20-hour mediation training, have 2 years of experience as a mediator or other equivalent experience, and must be willing to accept mediation referrals from Salem. Experience and knowledge in the areas small claims, civil law, and consumer debt are helpful.
