### PLEASE REMEMBER TO BRING YOUR SUMMONS AND YOUR PHOTO ID

**Immediately following general instructions the Grand Jury will begin its first session. The session will last part or all of the day.**

**PARKING:** You received a parking permit with your summons. Please detach and visibly display it through the windshield on the passenger side of your vehicle. You may park free in any legal public parking place in the City. You may also park free at the **Victory Parking Garage** located on Amherst and Vine Streets. Please make sure to also display your permit through the windshield when parking in the garage. This permit is valid Monday through Friday, 7:30 AM to 5:00 PM and only while in attendance in Court. Use of the permit at any other time is prohibited and subject to a ticket by the City.

**Meter or posted permit parking is NOT ALLOWED in The Federal Building Pine Street Lot or the Double Tree Parking Garage. PARKING BEHIND THE COURTHOUSE IS ALSO STRICTLY PROHIBITED.**

**SECURITY:** The Courthouse is a secure environment. Every person entering the Courthouse must pass through the metal detector. Please check our web page [www.courts.state.nh.us](http://www.courts.state.nh.us) for further information.

**LUNCH:** Lunch is not provided for grand jurors. Jurors will be allowed to leave the building during the lunch break

**ATTENDANCE:** Certificates of Attendance, if required by your employer, are available from the Jury Clerk.
