Sullivan County data includes cases from the 5th Circuit Court in Newport. This court's jurisdiction extends to New London, Newbury and Wilmot, towns located in Merrimack County.

Merrimack County data includes cases from the 6th Circuit Court in Franklin. This court's jurisdiction extends to Tilton and Sanbornton, towns located in Belknap County.

Merrimack County data also includes cases from the 6th Circuit Court in Hillsborough. This court's jurisdiction extends to Antrim, Bennington, Hillsborough, Deering, and Windsor, towns located in Hillsborough County.

Cheshire County data includes cases from the 8th Circuit Court in Jaffrey. This court's jurisdiction extends to Greenfield, Greenville, Hancock, New Ipswich, Peterborough, Sharon and Temple, towns located in Hillsborough County.
